Magdhawga Ugu Yar

- Magdhawga ugu yar waxa lagu bixiyaa hal daqiiqo, qaabkii mayl kasta. Laga bilaabo Janaayo 1, 2027, iyo Janaayo 1 kasta ka dib, magdhowga ugu yar waa in lagu hagaajiyaa sanadkiiba iyadoo la raacayo habraaca la midka ah mushaharka ugu yar ee gobolka Minnesota oo dhan sida uu dhigayo Xeerka Minnesota qaybta 177.24, qodob hoosaadka 1 .
- Gunnada hadda ugu yar waxaa ka mid ah:
 - \$1.28 maylkiiba iyo \$0.31 daqiiqdiiba gaadiid kasta oo darawalku qaado;
 - haddii ay khuseyso, \$0.91 dheeraad ah halkii mayl kasta gaadiid kasta oo fuushan darawalka baabuurka kaas oo ku xiran shuruudaha qaybaha [299A.11](#) ilaa [299A.17](#) , iyadoon loo eegin in qalabka lagu ilaalinayo kursiga curyaanka la isticmaalo;
 - Haddii codsiga safarka uu baajiyo darawal ama TNC ka dib markii darawalku mar hore u dhoofay si uu u soo qaado, 80 boqolkiiba kharashka burinta ee uu bixiyo darawalku; iyo
 - ugu yaraan, magdhow dhan \$5.00 gaadiid kasta oo uu darawalku raaco.
- Darawaliinta waa in lasiiyaa gunnada ugu yar ee mudada dakhliga oo aan ka badnayn 14 maalmood. Gunnada ugu yar lama dhimi karo.

 - Codsiga xuquuqaha iyo daawaynta lagu heli karo cutubka 181C ma dhaafi karo darawalku ka hor ama bilowga garqaadka u dhexeeya darawalka iyo UZURV.
 - Ilaa inta ay suurtoagal tahay, UZURV waa in ay Minnesota u isticmaashaa goobta gar-qaadista darawalka Minnesota.
 - Haddii garqaadku aanu ka dhici karin gobolka Minnesota, darawalka waa in loo oggolaadaa inuu ku soo muuqdo taleefoon ama qaab kale oo elegtaroonig ah oo uu dabaqo xuquuqda iyo daawaynta lagu heli karo cutubka 181C.
